Overview:

The S.T.A.B.L.E. Program is a pre-transport stabilization, post-resuscitation course designed to assist caregivers in the care of newborns. The purpose of this learning activity is to teach health care professionals the knowledge and skills required to successfully stabilize a neonate for transfer to a higher level of care or for admission to the NICU.

Objectives:

At the conclusion of this activity, the participant will be able to:

1. Improve patient safety for infants by: (a) standardizing processes and approach to care; (b) encouraging teamwork; (c) identifying areas where medical errors can and do occur; and, (d) reducing and eliminating preventable adverse events and errors.
