<u>Purpose</u> – This educational activity will formalize consistent practice among healthcare providers in the NICU on specific issues surrounding the evidence-based management of the less than 1500 gram infant.

<u>Learning Outcome</u> – Participants will learn how to improve outcomes by 1) improving interprofessional team-oriented communication through the use of the Risk Benefit Assessment approach, and 2) improving consistency in practice by reviewing and addressing current protocols with current evidence-based literature.

<u>IOM Competencies</u> – This educational activity will address 1) Provide patient centered care; 2) Work in interdisciplinary teamwork; 3) Employ Evidence-based practice; and 4) Apply quality improvement.

Objectives — At the conclusion of the activity participants will be able to 1) Interpret practice B/P guidelines and when to notify Neonatologist/Nurse Practitioner; 2) Identify which pressor most effective for underlying cause; 3) Discuss outcomes in infant with PDA medication/ligation management versus conservative medical management; 4) Identify patients that may need ligation/coil/or medical management; 5) State 3 differences in preterm and term protocols for bilirubin management; 6) Define how phototherapy effects bilirubin; 7) Identify 3 common causes of elevated direct bilirubin levels; 8) Interpret practice guidelines for transfusions and indicate feeding or NPO; Prince 3 implications of elevated reticular transfusions.

9) Discuss 2 implications of elevated reticulocyte count; and 10) State 2 reasons to limit platelet transfusions.
